

## CHANGE IN SHARE CAPITAL OF AQUAFIL S.P.A.

Milan, March 21, 2018 – Pursuant to article 85-bis of Consob's Issuers Regulation and to Article 2.6.2 of the Regulation of Borsa Italiana S.p.A, Aquafil S.p.A. [ECNL IM] announces the new composition of the equity share capital, resulting from the first Exercise Period of *Market Warrant* Aquafil S.p.A. (**Warrant**), relating to February 2018.
